A. GENERAL PROJECT DESCRIPTION.

1. Project Background.

The Ministry of Health has been interested in the planning of outpatient facilities in twenty two hospitals scattered all over the republic. These facilities are particularly desired by the Department of Curative Services which sees its service role in the many parts of the republic constrained by the lack of such facilities.

The Department has requested planning help from donors, - and US.AID has responded - so as to enable it to prepare presentations for use in negotiating with donors for funds to impliment the project.

2. Project Objectives.

The initial objective is to do funding preparatory work through the assistance of US.AID donor funds.

It is hoped that the report so produced will be useful to the Ministry of Health in negotiations with donors.

Secondarily data generated in this project will be of use to donors and Ministry of Health in planning the implimentation of a revamped curative medicine programme.

3. Project Benefits.

The Ministry of Health has been fortunate in that donors have previously funded facilities which cater to very small catchment areas and provincial catchments. In terms of overall rural health needs, there has developed, over time, a gap in the delivery of health care, especially surgical care at an intermediate level. At that level, there is need for extensive outpatient clinics, able to service the clients who are referred by lower level facilities. Twenty two sites have been identified by the Ministry as needing good general theatres which will in addition handle gynaecological family planning surgical needs. It is expected that there will be extensive surgical referral demand at the intermediate level as lower facilities refer patients upward. This will reduce costs for users dramatically.

The long-term benefit of the outpatient programme will specifically be in delivering more comprehensive and therefore better health care to the rural populations.

B. PROJECT TASKS.

- 1. To prepare cost estimates for the construction of twenty two outpatient departments including drawings.
- To prepare, collect and analyse socio-economic data of the catchment populations for each of the twenty two outpatient departments.

C. METHOD OF IMPLIMENTATION.

- 1. Preliminary Briefings and Existing Data Review.
 - a) US.AID. Briefing will be sought with the Office of Population and Health of the US.AID mission on the outset of the project. Specific information will be sought from them on the following:
 - i) Type of theatre envisaged.
 - ii) The tentative thinking about implimentation schedules of the project.
 - iii) Alternative sources of the theatre equipment which are significant in terms of costing the project.
 - b) Ministry of Health. Briefing will be sought to clear several important issues. Among these are:
 - i) The sequence of implimentation.
 - ii) Most desired space needs given the many types of outpatient departments existing.
 - iii) Long term needs of rural health care which may lead to demands being put on facilities in ways which to date have not been in use eg. theatre equipment for implimenting family planning surgery, not extensively done today, over and beyond normally desired rural theatres.
 - iv) Examination of the growth of other health facilities in the environs of the twenty two facilities to establish inter-facility distributions.
 - Alternative management systems of outpatient departments including theatres.
 - vi) Personnel coming on stream in future years for staffing the twenty two facilities.
 - c) Ministry of Finance and Planning. Briefing will be sought to clear following key issues:
 - i) Projected rural facilities plans.
 - ii) Projected demographics of catchment areas.

- d) Ministry of Housing and Physical Planning. Briefing will be on the following issues:
 - i) Classical construction costs for outpatient departments.
 - ii) Nyayo Ward type construction costs.
 - iii) Other alternatives.
- Department of Physical Planning. Briefing will be sought to clarify:
 - i) Long-term Physical Plans of the twenty two sites.

All key consultants will participate in the Preliminary Briefings and Existing Data Review Process and it should not take more than five days.

2. Field Work:

- a) Rationale. Field work will be done :
 - i) To examine sites.
 - ii) To collect patient information not available in Nairobi from District Level Officials who are charged with planning Health Care in the context of District Focus.
 - iii) To collect user need information from the local communities and local health and other government officials.

In conducting field work specific data on the following will be sought:-

- i) General outpatient buildings.
- ii) Theatre buildings.
- iii) Staff housing.
- iv) Ground work (including roads and parking) needed.
- v) Utilities needed.
- vi) Equipment needed.
- vii) Availability and suitability of land.
- viii) Population densities and growth rates and attendances.
 - ix) Existing and planned family planning use levels.
 - x) Labour force participation levels.
 - xi) Community education levels.
- xii) Community income levels.

b) Participants. We envisage to put six consultants in the field.

These are :

- i) Project Leader/Social Scientist.
- ii) Architectural Planner.
- iii) Architect.
- iv) Building Construction Specialist.
- v) Physical Planner.
- vi) Economist.

This is in keeping with our company's multidisciplinary nature where assignments are handled by a team rather than individuals. The six basic consultants' curricula vitae are included below.

c) Site Visit Organisation.

It is envisaged that the team will spend at least two days at each of the seven sites since supporting institutions in the environs will have to be quickly surveyed to establish what and how they will be feeding the new facilities.

It is important to note that of the seven sites, five will have to be visited by air. These are Wajir, Malindi, Kapsabet, Bungoma and Kisii. The other two ie. Karatina and Makindu will be visited by road.

It is envisaged that the full team will simultaneously participate in the field work in the interest of time.

As required in the invitation to tender document, a detailed workplan will be submitted after initial briefing and consultation.

3. Interim and Final Reports.

These Reports will be done in the Office in Nairobi.

Altogether it is envisaged that preparation of the Interim
Report will take ten days of the consultants' time.

Five extra days are planned for possible revisions and preparation of the Final Report. One day is budgeted for debriefing on the Interim Report.
