B. Scope of Work and Methodology

a. Introduction

From the documents it is clear that the ministry desires the consultant to essentially concentrate on the analysis of the already existing data.

This will essentially be collected from the Government, Tour companies, Hotel Chains, The World Bank, various Donor Countries, Churches and most significantly the County Councils and District Teams who will be involved in the joint development.

This study must also be seen in the context of the new district development focus which will shift the determination of development priorities to the districts (ministerial) decentralisation of Ministry of Tourism and wildlife staff to the districts, which is supposed to be completed by the 28th of August, will clearly shape what recommendations we are likely to give on several matters with regard to the planning and execution of the development of the circuit.

b. General Comments on Scope of Work

 For purposes of identifying the local physical tourist attraction features, it will be necessary to inventory them on the ground. This is taken care of in the subsequent travel budget.

Traditions and cultural aspects which are of attraction to the tourists are widely researched. We shall review and synthesize those which are relevant to tourism growth.

We will note the impact of tourism on local cultural traditions.

We shall examine Turkana, Marsabit and West Pokot new population concentration generated by famine relief related agricultural schemes. These are likely to grow because of activities planned by other ministries. We shall examine how they may provide labour pools and social cultural activities for tourist oriented industry.

2. This circuit has lagged behind because the road network is so absolutely terrible.

We shall examine how the tour companies who have tried to expand operations in the circuit by use of planes, have been constrained by the problem of moving the people around when they get on the ground.

We shall examine whether investors are willing to put large amounts of money into boats to beef up Lake Turkana operations.

Finally we shall examine how creation of parks competes for land with the already existing farming, pastoral and nascent fishing activity.

There may well be ways the economic activities could compliment tourist industry in the area.

We, by discussion with all the existing development authorities in the region, will phase the constraints over time.

3. Suitable sites for development of lodges will have to be identified on the ground. They have to fit basic criteria.

First is possibility of the future regional development plans of the region being able to supply the basis minimum services of roads, water and labour.

Secondly, in this circuit more than in others there, will be need for assuring security. Plans for this will be ascertained from the relevant quarters.

The third factor is scenic attractions which will be inventoried. They will form a major basis for the selection of sites.

4. Destination points will either be within parks or on the lakes. Already there are high cost operations at these points. These are operated by the very exclusive and therefore highly capitalised operators.

We assume that under this heading the idea is to find solutions to get mass tourism in the circuit and thus there will be need to come up with alternatives within the reach of the ordinary tourist.

Programmes will be identified which include the bread and butter activities of ordinary tourists i.e. game viewing and photographing, boating for pleasure, water skiing, snorkling and fishing, cultural dances, hiking, mountain climbing, camping, anthropological and historical sites, and the like.

Investigation of the artifacts industry capacity at destination points will be conducted.

5. Inventory of wildlife has gone on in the area under the ministry for quite some years. Although ideally there is need for ground check of ungulate wildlife species the low level budgeting of the study and the time precludes overall survey of the whole area. The Ministry of Tourism and Wildlife has collected some data over the years.

We shall analyse this data to show changes over time and relate the distribution to destination points.

6. Transportation circuits and sub circuits will essentially depend on whether the nearer circuits have surplus tourists to feed the northern bits further out. There is of course the already refected idea that the Central Circuit can stretch from Marsabit to Turkana cheaply. That leaves only the Pokot, Kerio and South Turkana as possible bits of the Northern Circuit to be fed from the Central Circuit

We shall examine the viability of:

- (a) Feeding Losai, Marsabit National Reserve and Sibiloi from existing circuits in Isiolo, Samburu and Meru districts.
- (b) The possibility of creating an independent Lake Turkana circuit which will need major investiments into water related activities on the lake.
- (c) How the roads to South Turkana could be developed, to link South Turkana National Reserve either to the lake circuit or
- (d) the Kerio Circuit.
- (e) How Nasolot and the Kerio Valley operations could be fed by the Western Circuit and the Central Circuit.
- (f) We shall further look in detail if the relative merits/demerits of how the major national central circuit could feed the subcircuit in the Kerio Valley.

Ways of relating Pokot to the Western subcircuit will be examined.

- (g) Since ongoing developments on the Turkwell River will greatly improve transportation, we shall examine whether the Western Circuit can be extended through Pokot to Turkana Central Island.
- 7. Local modes of transport will essentially be camels, boats and possibly donkeys. They need to be organised in terms of local investors.

The tour companies already using camels will be interviewed for costing purposes.

There is the basic problem of continuous movement of the peoples in the area. What we will establish is

- (a) The possibilities and the opportunity cost to the locals of establishing operations which can support these local modes and sustain them for a large numbers of tourists and people operating there.
- (b) How and where these local modes of transportation can be intergrated with the identified subcircuits.
- 8. Circuits and subcircuit study is enumerated in 6 above.

 We shall examine the possibility of creating a major

 marketing focus based on Lake Turkana, semidesert and

 desert attractions as a new focus for marketing Kenyan

 tourism in general and the Northern Circuit in particular.

We intend to analyse, at the national level the bed occupancy rates in all adjoining circuits to the northern one and to identify those which can maximise the flow of tourism into the area.

- 9. We shall carry out a cost benefit analysis of the identified options to develop the Northern Circuit taking to account (a) the new district focus strategy (b) development programmes by the Kerio Valley Authority (c) development plans of donor agencies (d) sociopolitical considerations.
- 10. We shall estimate the cost of wildlife conservation in the area and compare it with other ongoing/planned activities.

Given projected government development budgets, it is not clear that there will be monies coming for large scale parks as in the past. As in 9 above, the tradeoffs, we imagine will be limited. We therefore intend to only project available funds for development and show different returns if invested in other economic activities decided upon by national government, districts and donors.

The ministry is aware that significant external development funds will increasingly shift to the private sector. We shall take this into consideration in particularly evaluating the projected farming, irrigation, fishing and pastoral plans.

We are informed that the government strategy is to supply basic infrastructure and increasingly allow the private sector to take on the productive economic role. This is the focus of the ongoing investigations on parastatals. We will therefore seek to establish the possible futures for government investing in hotels, as opposed to private sector or local authorities. I midentally given district focus, and, the already apparent diminuation of the local authorities, we will investigate whether the government through the districts focus could get involved. To the extent that ministries will post technical staff to the districts this may be an opportune time for it to break the perrenial problem of county councils establishing parks and other infrastructure.

We shall therefore investigate through: -

- 1. GOK interviews, priorities and probable availability of funds for:-
 - (a) Infrastructure e.g. roads, water supply, electricity and airstrips in the study area.
 - (b) Lodges
 - (c) Wildlife conservation
- 2. Private Sector investment in:
 - (a) Lodges
 - (b) Transport
- 3. County Councils/Districts in any under 1 and 2 above.
- 12. We are not clear whether the ministry has solved the administrative problem of revenue sharing with County Councils. But given increased decentralisation, it may make sense to channel GOK involvement in the development of this circuit to the districts and Kerio Development Authority.

If this move materializes, it may allow contractural relations for services like national and international marketing to be costed and paid for by the bodies to the ministry.

Large amounts of foreign capital investment into the tourism sector are not envisaged since the rehabilitation of some of the circuits among our neighbours has attracted big chunks of it. The question we will therefore address is whether there are possibilities of attracting locally based capital into the region.

Similarly, given that increasingly donors have preferred to develop regions in an intergrated manner, we will liase with the GOK ministries responsible for these plans and the donors to establish the patterns of their funding to different sectors. This ought to give us new ways of looking at the question of revenue sharing. This implies that we shall have to examine new institutional mechanism for sharing costs and revenues.

C. Work Schedule

We propose to execute the project in three phases.

1. Phase One

This will consist of examination of the existing data and intensive interviews with government ministries, international agencies and tour operators, to prepare a preliminary analysis which will include:

- (a) Compiling of inventory and distribution of ungulate wildlife species, marine ecology and physical ecology of the study area.
- (b) Identification and assessment of the land use patterns and potentialities of the area.
- (c) Listing of ongoing and planned programmes by government and international agencies.
- (d) Identification of constraint to future development.
- (e) Identification of development role of government, private sector and local authorities.

- (f) Identification of existing methods for sharing and distribution of development costs and revenue and the problems.
- (g) Cost of wildlife conservation in the area.

2. Phase Two

This will include visits to the study area to:-

- (a) Identify and assess transportation circuits and sub-circuits in the study area including identification of local modes of transportation that may be attractive to tourists.
- (b) Identification and assessment of suitable sites for lodges and how they could be linked to the other infrastructure in the area.
- (c) Interviews and consultations with:
- (1) District Teams.
- (2) International agencies and church personnel in the study area.
- (3) Local authority officials.
- (4) Local leaders.
- (5) Kerio Development Authority.

Consultancies will be carried out in view of:

- (a) Updating information gathered in phase one.
 - (b) On the spot check of the potentials and the problems of developing tourism in the area.
 - (c) To get feedback on points a) and b) of phase two

3. Phase Three

Data analysis and Report Writing. In addition to the data obtained in phases one and two we intend to carry out the following analysis:-

- (a) Cost benefit analysis of wildlife conservation as opposed to other economic activities in the area.
- (b) Estimate benefits which will accrue to the local people and communities and the national economy.
- (c) Linking of the existing Northern Zone subcircuits and Western Circuit with those identified in the study.

NORTH COAST/TANA ZONE SPECIAL STUDY

1. INTRODUCTION:

The Wildlife Conservation and Management Department has identified 6 major tourism circuit zones each incorporating key tourism attractions and wildlife areas. These are:-

- 1. Southern Circuit
- 2. Central Circuit
- 3. Coastal/Marine Circuit
- 4. Western Circuit
- 5. Northern Circuit
- 6. North Coast/Tana Zone.

These areas are unique and different from one another. Some of the zones have been developed and well exposed to tourism and yet there are some of them which have not been well understood in terms of their resources and potentials as tourists attractions.

North Coast/Tana Zone is one such undeveloped tourism circuit area which include Arawale, Rahole and Boni National Reserves in Garissa District; Dodori and Kiunga Marine National Reserves in Lamu District and Tana River Primate and Kora National Reserves in Tana River

2. PURPOSE OF STUDY:

Wildlife Conservation and Management Department is interested in the future of North Coast/Tana Zone and especially what potentials it has to be developed as a major tourist destination in light of its wildlife, marine and tourist resources. The Wildlife Conservation and Management is therefore requesting proposals for a study which would provide an inventory of wildlife, marine and tourist resources in this zone and what kind of development input is necessary to develop this area as a tourist attraction. The study should be able to link this area with the already existing tourist circuits particularly Southern and Central circuits.

3. STUDY AREA:

The area under study includes Arawale National Reserve, Boni National Reserve, Dodori National Reserve, Kiunga Marine National Reserve and their immediate environs as indicated in their border plans, taking into account the Tana River basin as a whole and Lower Tana in particular. To the south of this region the Tsavos and the north the Meru Park and the mountain region of the Central zone.

4. SCOPE OF WORK:

The consultant will gather and analyse past and present information and describe future proposals presently being considered, by consultation with various government and international agencies which are interested in the area. The end result should outline the scenic, wildlife, marine and tourist resources in the area and propose a number of development strategies for the zone which link it with the existing tourist circuits and should examine the following aspects. Aspects of cultural diversity must also be highlighted as an attraction in its own right.

- (a) Identify local tourist attraction and features including traditions and culture.
- (b) Identify constraints to future development.
- (c) Selection of suitable sites for lodges/tourism infrastructure.
- (d) Develop lists of programmes/facilities/activities at destination points.
- (e) Inventory and distribution of ungulate wildlife species.
- (f) Identification of transportation circuits and sub-circuits.
- (g) Identification of Local modes of transportation and other traditional activities which would be considered as exotic by tourists e.g. the use of camels and traditional canoes.
- (h) Identification of how tourist circuits could be linked and intergrated to maximise marketing of Kenya as a tourist destination in general and North Coast/Tana Zone in particular.
- (i) Initial costing and feasibility analysis of preliminary development options/concepts.
- (j) The cost of Wildlife Conservation development strategy for tourism as opposed to other economic activities of the region.
- (k) Identification of developmental role of government versus the private sector and local authorities.
- (1) Study and recommend methods of sharing and distribution of development cost/revenue accruing from common services to government and respective local authorities as well as the private sector.

5. ADMINISTRATION OF THE STUDY:

- (a) The work ideally, should be undertaken by an interdisciplinary team which must include an economist, ecologist, marine biologist, a resource planner, a transportation planner, and access to a quantity surveyor.
- (b) An upper limit of Kenya Shillings 250,000/= is budgeted for the study.
- (c) The final report must be presented not later than three (3) months after the signing of the contract.
- (d) All personnel to be involved in the study must be listed in the study proposal with pertinent professional information and each of them must be prepared to discuss issues with the Steering Committee.
- (e) All personnel involved in the study will have to be available to the contractor during times of work review.
- (f) Proposals must stipulate the methods to be used in carrying out the required work.
- (g) Specific tasks and time estimates (men-days) will be required for all personnel involved in the study.
- (h) Proposals must include budget estimate with a clear delineation between fees and expenses including possible sub-contracting.
- (i) At least one progress report will be required and a presentation before steering committee of the final study results. Other meetings may be held at the request of the successful consultant or the contractor or by the steering committee.
- (j) The consultant will be required to submit ten copies of the final report plus one clear original copy suitable for reproduction.
- (k) Proposals must be received by the Wildlife Conservation and Management Department not later than 10.00 a.m. on 25/8/83.
